## Drug Conviction Certification

Drug conviction certification is required both on the federal and state level. The drug certification at the federal level is asked on your Free Application for Federal Student Aid (FAFSA).

The drug certification at the state level is required through your acknowledgement of the following question. Please use caution when answering the below question as mistakes or inaccuracies will delay the processing of your funds.

*Have you ever been convicted of a felony or an offense under Chapter 481, Health, and Safety Code (Texas Controlled Substances Act)*

OR

*under the law of ANY other jurisdiction involving a controlled substance as defined by Chapter 481, Health and Safety Code?*

## Child Support Certification

Dallas College requires verification of your eligibility to receive state funds. Please use caution when completing this form, as mistakes or inaccuracies may result in delays in the processing and/or distribution of state funds.

Texas Family Code, Section 231.006, Ineligibility to Receive State Grants or Loans or Receive Payment on State Contracts, prohibits the payment of state funds under a grant, contract, or loan to a person, including a student, who is obligated to pay child support and is more than 30 days delinquent in paying that child support.

Texas law further provides that a person, including a student, who is ineligible to receive payments for the reason state above shall continue to be ineligible to receive payment from the state under a grant, contract, or loan until:

- all arrearages have been paid.
- the obligor is in compliance with a written repayment agreement or court order as to any existing delinquency; or
- the court with jurisdiction over the child support order has granted an exemption from the obligation as part of a court-supervised effort to improve earnings and child support payments.
