

DALLAS COLLEGE  
RESOLUTION ORDERING AN AMENDMENT TO THE ORDER OF  
ELECTION

WHEREAS, on December 7, 2021, the Board of Trustees of Dallas College ordered an election to be held on May 7, 2022, for the purpose of electing four (4) members to the Board of Trustees of Dallas College, one in each of the Trustee Districts 1, 2, 3, and 4;

WHEREAS, this Board has adopted an order declaring the unopposed candidate for Trustee District 4 elected to that office and cancelling the election in Trustee District 4;

WHEREAS, the Board of Trustees is authorized and intends to enter into an agreement with the Dallas County Elections Department, and numerous other public entities, to conduct the May 7, 2022, Dallas College Board of Trustees election;

WHEREAS, this Board also desires to include in that election order, the phone number, email address, and internet website of the early voting clerk for the May 7, 2022 election;

WHEREAS, Dallas County, including the Dallas County Elections Department, is subject to the bilingual election requirements of Section 203 of the Voting Rights Act (VRA), 52 U.S.C. § 10503, with respect to persons of Hispanic and Vietnamese Heritage, which is applicable to all elections conducted in the jurisdiction, including the May 7, 2022, Dallas College Board of Trustees election;

NOW THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF TRUSTEES OF DALLAS COLLEGE:

That in accordance with the laws of the State of Texas pertaining to the election of Trustees, the Board does hereby amend its prior Election Order Resolution to declare an election for Trustee Districts 1, 2, and 3 only for the May 7, 2022, Dallas College Board of Trustees election and any runoff, if necessary; to provide a version of the Order of Election in Spanish and Vietnamese, as required by the VRA; and to add the phone number, email address, and internet website of the early voting clerk for the May 7, 2022 election. A copy of the amended Election Order Resolution as adopted by this Board is attached and made a part of this resolution.

## ELECTION ORDER RESOLUTION

WHEREAS, Section 3.004, Election Code, and Section 130.082, Education Code, requires the Board of Trustees of Dallas College to order an election to elect certain members of the Board of Trustees in even-numbered years; and

WHEREAS, a vacancy occurred in District 1 during 2021 which resulted in the need to call an election in May 2022 for the unexpired term of that office until May 2024; and

WHEREAS, various provisions of the Election Code require the election order to contain certain information; NOW THEREFORE;

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF DALLAS COLLEGE:

Section 1. That an election shall be held on the first Saturday in May 2022, which is the seventh day of May 2022, to elect a total of three (3) members to the Board of Trustees of Dallas College, one in each of the Trustee Districts 1, 2, and 3, provided that, for District 1, only, such election shall be for election to office to serve the unexpired term of that Trustee District term of office until May 2024. The election for Districts 2 and 3 shall be for a term of six (6) years.

Section 2. That Michael J. Scarpello is the early voting clerk for the May 7, 2022, election. Early voting by mail shall be conducted at:

Applications for ballot by mail may be filed beginning January 1, 2022, through April 26, 2022.

The main early polling location for voting by personal appearance is the George L. Allen Sr., Courts Building, 600 Commerce Street, Dallas, Texas 75202, and other locations as designated by the Board of Trustees of Dallas College.

Early voting by personal appearance dates and times:

April 25 thru April 29	(Monday - Friday)	8:00 am to 5:00 p.m.
April 30	(Saturday)	8:00 am to 5:00 p.m.
May 1	(Sunday)	1:00 pm to 6:00 p.m.
May 2 & May 3	(Monday & Tuesday)	7:00 am to 7:00 p.m.

Section 3. That the date of the final canvass of returns for the May 7, 2022, election is Wednesday, May 18, 2022, at 1601 Botham Jean Boulevard, Dallas, Texas 75215, and the presiding officer of the canvass is Monica Lira Bravo.

Section 4. That simultaneously with the adoption of this resolution, a Spanish and a Vietnamese version of this resolution is adopted.

Section 5. That this resolution is effective upon adoption by the Board of Trustees of Dallas College and that this resolution shall be signed by the Chair of the Board of Trustees.
