## RESOLUTION CANCELLING THE ELECTION FOR TRUSTEE DISTRICT 4 AND DECLARING THE UNOPPOSED CANDIDATE ELECTED

- Section 2. That the election on May 7, 2022, is canceled for Trustee District 4.
- Section 3. That the following candidate who is unopposed for the May 7, 2022, election is declared elected to office, and the Vice Chair shall issue a certificate of election to: Monica Lira Bravo, Member, District 4.
- Section 4. That in accordance with section 2.053 of the Texas Election Code, on election day a copy of this resolution shall be posted at each polling location used or that would have been used in the election.
- Section 5. That simultaneously with the adoption of this resolution, there is adopted a Spanish and a Vietnamese version of this resolution.
- Section 6. That this resolution is effective upon adoption by the Board of Trustees of Dallas College and that the Chair of the Board of Trustees shall sign this resolution.
