Please note: If the major stated on your I-20 does not match what you indicated on your application, then you may have chosen a selective admission program that can only be entered after you have completed prerequisites and have been selected for the program.

**Translations:** Any document containing a foreign language shall be accompanied by a full, professional English language translation in which the translator has acknowledged as complete and accurate and that he or she has the necessary skill and certification to translate official documents from the foreign language into English.

**Change of Status:** Dallas College will review requests for change of status to an F-1 on an individual basis. Please be aware that the quickest path to enrolling as an F-1 student may be to return home and apply for an F-1 visa in your respective country of citizenship. If you are admitted at Dallas College for F-1 change of status, a Designated School Official (DSO) will only issue an I-20 and letter of acceptance, as it is the applicant's responsibility for filing the proper paperwork within the appropriate timeframe, requesting deferral when necessary, and/or seeking assistance from an immigration attorney. Not all applicants are eligible for a change of status.

**I-20 Education Level:** Dallas College issues Language Training, ESL Pathways, or Associate Level I-20s. The program indicated on your I-20 will depend on official Proof of English Proficiency AND any admission testing that is completed prior to acceptance. The education level of your I-20 may be changed upon arrival and after TSIA2 College-Readiness and/or ESOL placement testing.

**Academic Standing:** Dallas College international F-1 admissions require additional proof of normal academic progress for F-1 applicants who previously had a non-acceptable scholastic performance with Dallas College. F-1 applicants with a previous academic standing of Suspension (SUSP), Academic Dismissal (DISM), or Indefinite Academic Dismissal (IDIS) with Dallas College must be currently enrolled with an SEVP recognized college or university level institution and must also provide official transcripts showing an established current credit Grade Point Average of 2.00 or higher.

**Fraud:** Any falsification of any information that you provide is grounds for denial, withdrawal, or cancellation of your international admission application with Dallas College.
