Welcome to the new academic year at Dallas College! I hope you're staying cool as we all look to Fall and cooler temperatures.

We kicked off the new semester with Conference Day, focusing on the great things happening with our Dallas College students.

The best part -- being inspired by the praise and gratefulness our students showed for the support and encouragement they receive from the faculty and staff at their respective Dallas College campuses. From our on-campus food pantries and clothes closets to our childcare support, we heard several stories about the difference Dallas College is making in the lives of our students, and we continue to pursue that goal each day.

Speaking of childcare, we are moving forward with our goal of expanding support of our student parents. Dallas College is now the first higher ed institution in Texas to partner with the Bezos

Academy offering tuition-free, on-campus early childhood education centers. Most importantly, this addresses a longstanding need within our community.

Our Cedar Valley campus Academy has been operational since last Spring, and the Mountain View Academy is expected to open November 1. The Bezos Academy at Mountain View will open with 30 students with one English-as-a-first-language classroom, and one classroom that is dual language. Our Bezos Academy locations have had a tremendous response, and there is currently a waiting list at both.

Earlier this month, we invited the community to join us for a conversation on our \$1.1 billion bond that voters overwhelming approved in 2019. We discussed our vision for a downtown innovation hub and a new El Centro campus and received welcome insight from those we serve across Dallas County. We look forward to bringing this form of next-level support to downtown Dallas.

We are also excited to see the progress being made on the more than 50,000 square feet of educational space we're working on at the Red Bird center. For the southern Dallas County community, this workforce development center will help Dallas College provide more space for educational and employment opportunities, extending the effectiveness of higher education beyond our classrooms.

As you can see, the semester is off to a fantastic start as we remain steadfast in our mission to transform lives through higher education. The positive impact we're making across Dallas County is evident, and I hope you are as proud as I am of what we're accomplishing at Dallas College. Thank you for your continued support as part of our Dallas College family.

Joel Klump Continues a Family Legacy at Dallas College

A member of Joel Klump's family — himself included — has either taken classes at or worked at Dallas College from the time it was founded until today.

"This college has been a part of my life as long as I can remember," he said. "Its history is my history."

Klump's mother, Claire Gauntlett, graduated in the first class of Dallas College's El Centro Campus. She later earned her Ph.D. in administrative education and returned to Dallas College, where she worked for 36 years.

Klump remembers his mom dropping him and his younger brother off at the gym at Richland Campus during the summer while she taught a government class in the mid '70s.

As a teenager, Klump took scuba lessons at Richland, earning his scuba license before he had even graduated high school. Both he and his brother took classes at Dallas College after high school, and both would eventually graduate from Dallas College's Eastfield Campus.

Following in his mother's footsteps, Klump has enjoyed a 25-year career in higher education — most of which has also been spent with Dallas College.

Supporting Each Other

Klump worked for Collin College for a while before applying for a position with TRIO at the Eastfield Campus, where his mom worked at the time.

"We worked together here for about four years. And for the first two of those years, I was known as Dr. Gauntlett's son. The last two years she was known as Joel Klump's mother." Klump said, smiling. "That made me feel good."

While Dr. Gauntlett retired 12 years ago, Klump is still at Eastfield. He's held several different positions over the years, including in continuing education and in admissions. Today, he's the senior administrative assistant for the Office of Student Success, providing support to the dean of Admissions and other administrators.

Klump is perhaps most known for providing exceptional customer service, not only to students, but also to his fellow staff members. In fact, in his spare time he's currently reading "The Service Culture Handbook."

"I've worked in a lot of different departments within the college, and so if anybody comes to me with anything I won't turn it down, whether it's helping a student, or a staff or an administrator."

For many Eastfield employees, Klump is the first person they see in the morning when they get to work. He shows up early so he can stand in the lobby and greet staff as they arrive on campus.

"We are all here to support a greater cause, sometimes that's supporting students, sometimes that's supporting each other," said Klump. "I try to support the staff by just being a friendly face that they see every morning when they walk in that door."


Measuring Success

Part of Klump's role includes taking the official minutes for the Board of Trustees meetings, which provides him with unique insight into how his work is directly connected to our students' experience. And this ability to impact students' lives is the reason why he loves coming to work every day.

"I really love my job. You'll never meet another person with the college who loves coming here more than I do," he said. "I get to make people's lives better — both students and staff."

As for the legacy he hopes to leave at Dallas College, he shared, "My success will be measured by those I have helped to fulfill their dreams of a better life, and the people they help because someone helped them."

"I was reminded of that just this morning when I stopped at the grocery store to get some food for a birthday party at work. A female employee at the store saw my nametag and stopped me to tell me that she just graduated from Cedar Valley. I shared her excitement and gave her a hug. That never gets old."





Fall Enrollment begins October. 30, 2023



The Fall Enrollment period for Medicare-eligible retirees in the Texas Employees Group Benefits Program (GBP) is Oct. 30 through Nov. 17. It is the only time of the year you can enroll in coverage for yourself and/or your eligible dependents without a qualifying life event (QLE). All changes made during this period are effective January 1.

What's new for Plan Year 2024?

- Express Scripts, Inc. will be the new administrator of the HealthSelectSM Prescription Drug Program and HealthSelectSM Medicare Rx starting January. 1, 2024.
- EyeMed Vision Care, LLC (EyeMed) became the new administrator for the State of Texas VisionSM program September 1, 2023.
- Premiums for the HealthSelectSM Medicare Advantage Plan will increase by about 5–7%.
- Premiums for DeltaCare® USA dental health maintenance organization (DHMO) will increase slightly. They'll be back to PY22 rates, after a one-year decrease due to a COVID-19-related refund from Delta Dental. You'll find more information in your Fall Enrollment packet.
- HealthSelectSM Secondary plan's total annual in-network out-of-pocket maximums will increase to align with IRS maximums.

Why are Medicare Advantage rates increasing?

Premiums are increasing by about 5–7% due to higher medical and prescription costs. However, the Plan Year 2024 premiums are still lower than they were in 2020, before UnitedHealthcare became the insurer of HealthSelectSM Medicare Advantage.

Watch for your enrollment guide in the mail.

Your Fall Enrollment packet will have helpful details about these changes, and more. ERS will send your packet in October with information about your benefits. You also can visit the Fall Enrollment page on the ERS website to view the Fall Enrollment guide, premium rates and information from plan administrators.

Enrolling in/dropping coverage outside of Fall Enrollment

To enroll in coverage outside the Fall Enrollment period, you must have a QLE, such as marriage, divorce or loss of other coverage. Medicare-eligible retirees may drop any coverage, reduce optional life insurance coverage or change from one health plan to the other any time of year without a QLE. If you are a retiree who is not eligible for Medicare, your enrollment

The Nominating Committee is recommending a bylaw change regarding the Vice President position. Should the change be accepted by the membership at the December meeting, the position's new title will President Elect.




Visit to Arboretum

Nasher Sculpture Garden



Bob Chambers coordinated a great summer tour on Friday, June 9, 2023, at the Nasher Sculpture Garden to see "Mark di Suvero: Steel Like Paper."

I don't know if the name Mark di Suvero rings a bell, but I feel sure you have seen his work. There are several monumental works around Dallas, giant constructions of red-orange steel I-beams welded together. One of them, called Ad Astra, dominates the central space in the back hallway of North Park Mall; another one, called Ave, stands on the front lawn of the DMA. There was one called Proverb near the Meyerson in the Arts District for a time. Because there were a number of pieces here, I always assumed he was a Texas artist, but I have learned that he is a pivotal figure in the history of contemporary sculpture. He is part of a Jewish family who moved to America at the beginning of WWII. While getting a BA in philosophy at UC-Santa Barbara, he worked in construction and began using cast off materials in sculpture. He became a pioneer in the use of the crane in sculpture, building his works "from beginning to end, with I-beams and using a crane, solely by himself." After his first show in New York, the editor of *Arts Magazine* wrote, "From now on nothing will be the same." He called the body of di Suvero's work "at once so ambitious and intelligent, so raw and clear, so noble and

accessible, that it must permanently alter our standards of artistic effort." His works are now known all over the world; he was awarded the National Medal of Arts in 2011 by President Barack Obama.

The Nasher exhibition is "the first museum investigation of the artist's studio practice and the most extensive survey of his work in over 30 years."



Hairspray



A group of retirees attended the musical *Hairspray* at the Booker T. Washington High School for the Performing and Visual Arts on Saturday afternoon, September 16, 2023. *Hairspray* is an American musical with music by <u>Marc Shaiman</u> and lyrics by <u>Marc Shaiman</u> and <u>Scott Wittman</u>. The songs include 1960s-style dance music and "downtown" <u>rhythm and blues</u>. Set in 1962 <u>Baltimore</u>, <u>Maryland</u>, the production follows teenage Tracy Turnblad's dream to dance on *The Corny Collins Show*, a local TV dance program based on the real-life <u>Buddy Deane Show</u>.[1] When Tracy wins a role on the show,

she becomes a celebrity overnight, leading to social change as Tracy campaigns for the show's integration.

After the event, the group enjoyed an early dinner at the Downtown El Fenix Restaurant.

2023 Scholarship Recipients



The scholarship selection committee was comprised of Ed Garcia, Lisa Theriot, John Wells, and Georgia Francis, chair. We had 31 applicants, the most we've ever had. The committee was very impressed with the quality of the majority of the applicants. Lisa decided we could give two scholarships this time. The scholarships are \$1,000 for the spring semester. The two recipients are Skeikh Abdullah and Maris Rodriguez. The answers to the questions they must complete as part of the application process are included here.

ESSAY

Maris Rodriguez

Why are you applying for the Dallas College Retirees Association Scholarship? Why do you believe you are a good candidate to receive this scholarship? Describe academic goals and future career plans. Include community service activities you have participated in and/or leadership roles have you held. Provide any further information in support of your application.

My previous experiences have prepared me to push myself to try new opportunities and pursue higher education, even when I must face feelings of discomfort and self-doubt. At fourteen, I dropped out of high school due to personal reasons such as mental health. At age twenty, I decided that I needed to push myself to continue my education. I applied to Dallas College and took the Texas Success Initiative (TSI) to test into college. Who I am today is the result of my determination to succeed and the push I gave myself to try new opportunities to better my life. I went from being a high school dropout to a Mathematics major with a 4.0 GPA, an active honors student with my college, and a member of Phi Theta Kappa, The National Society of Collegiate Scholars, and the Dallas College STEM League.

In the Fall semester of 2022, I participated in the Dallas College Miniterm program with Jacobs Engineering for 10 weeks. In this externship, I work with five other students to conduct research on a project given to us by the host company and we would take turns being the team lead. At the end of the 10 weeks, we presented our research in front of the Jacobs company. This experience gave me leadership, teamwork, and public speaking skills.

Outside of school, I have been a volunteer cage cleaner for the non-profit organization New Beginnings Cat Rescue since March 2021 where I assist and care for cats who are awaiting adoption. In 2020, I volunteered to handmake twenty masks for Frontline Workers to help reduce the spread of COVID-19 with OptumRx Health Systems. Whether it's helping animals or humans, I want to make an impact that can improve my community because any amount of aid adds up to making great changes.

After my time at Dallas College, I want to transfer to my dream university, the University of Texas at Austin, where I will double major in Mathematics and Astronomy. After I earn my master's degree, I want to become a mathematician and do research with NASA. Since I did not earn a high school diploma or equivalent, I am unable to apply for federal aid and I must pay for college out of pocket. Receiving the Dallas College Retirees Association Scholarship would financially aid my success as a college student and help me on my academic journey. I am a good candidate for this scholarship because I



have shown I am determined to complete my education and have a clear vision for my future. This scholarship will help me to continue to obtain my academic goals and pursue my career goals.

My name is Sheikh Abdullah, and I have successfully completed 18 credit hours of coursework as a computer science student at Dallas College. My goal is to become a cybersecurity specialist. Science has always piqued my curiosity. I enjoy working with electronic gadgets and seeing how things work with software. However, I discovered that while I understood hardware, I still needed a thorough understanding of software to fully comprehend the entire operating process and achieve my goal. Thus, I intend to get my cloud computing certification as soon as possible and continue to do a bachelor's in computer science.

I see the path to my goals as a process of incremental acquisition of knowledge and experiences. In the long term, I'd like to concentrate on cybersecurity because it's something I'm passionate about and one of the most marketable careers today. As there are different levels of cybersecurity, I want to start at the beginning by getting training and getting a job in the field, and then continue to get more training and certification throughout my bachelor's degree, so that when I graduate, I will have a computer science degree and experience in the

same field. This is a path I have been able to follow successfully through my education in the past.

I live alone because my parents and all my family members are in Nepal. I am responsible for all my expenditures, including rent, groceries, insurance, college tuition, and study supplies. My father is a farmer in my home country, and they have extremely few resources. They are unable to contribute much to my education fees due to a lack of funds. On the other hand, I am required as the oldest son to help my parents financially so they can take care of themselves and provide for the health and education of my brothers and sisters. This means that a significant part of the money I earn is not available for me to cover the expenses of my education. Nevertheless, if I receive this scholarship, the funds from it will be used to cover the cost of certifications and study tools like a laptop, software applications, and gadgets to stay current in today's environment.

At Dallas College, I am an active member of TRIO and Phi Theta Kappa. I participate in leadership work for many projects as a member of this. We are currently working on a project called "Female Participation in Games" where we will gather information on the percentage of female participation in contrast to male participation. We'll be doing research to find out why there are fewer women playing games and what we can do to change that.

The Dallas College Retiree Association Proposed Change of Bylaws

A committee met and adopted the following changes in the bylaws which will be voted on at the Holiday Luncheon Business Meeting.

Article IV-Officers and Their Duties

 members and guests attending luncheons/business meetings.

Texas Community College Teachers Association Is for Retirees




The Texas Community College Teachers Association ("TCCTA") is a broad-based professional association for community college faculty and administrators. It also offers many benefits to retirees. TCCTA is vigilant in the area of retirement and health benefits.

The Teacher Retirement System of Texas ("TRS") is one of the largest and most financially stable defined benefit retirement systems in the United States. With more than \$150 billion in assets under management, TRS is not only a state agency, but a major financial institution in its own right, with attendant internal management complexities, external economic stresses, regulatory obligations, and political exposure. As a defined benefit system, with its obligation to pay earned benefits to retirees for life, TRS has to be administered with a long-term view to serve both present and future retirees. Its mission is vital to the financial lives of members depending on their monthly payments, faculty working toward retirement, and recruitment of the next generation of college teachers.

When negotiations were occurring on whether to give TRS recipients a cost-of-living adjustment Richard Moore, Director of TCCTA, and Beamon Floyd, TCCTA Lobbyist, sat at the table as negotiations were presented to the Texas legislature to propose a constitutional amendment authorizing the 88th Legislature to provide a cost-of-living adjustment to annuitants of the Teacher Retirement System of Texas. TCCTA knew that funding a cost-of-living increase for TRS recipients would be the first in 20 years.

TCCTA must be maintained by members interested in maintaining this diligence and a seat at the table with TRS through its annual membership of \$35.00 a year. Many retirees think that joining TCCTA after retirement is not in their best interest, but retirees benefit immensely from negotiations between TCCTA and TRS.

Proposition 9

Texas Proposition 9, Cost-of-Living Adjustments for Teacher Retirement System Amendment (2023)

The following information was published by the Texas Legislature regarding Proposition 9 that will appear on the ballot during the November 7th election. Early voting starts on October 23rd. If approved, this proposition would allow the Texas Legislature to provide a cost-of-living increase for annuitants for the Teacher Retirement System of Texas.

Proposition 9 (H.J.R. 2, 88th Leg., R.S.)

The constitutional amendment authorizing the 88th Legislature to provide a cost-of-living adjustment to certain annuitants of the Teacher Retirement System of Texas.

Summary Analysis

H.J.R. 2, 88th Legislature, Regular Session, 2023, proposes a temporary amendment to the Texas Constitution that authorizes the current 88th Legislature to (1) provide by general law a cost-of-living adjustment to certain annuitants of the Teacher Retirement System of Texas and (2) appropriate state money to pay for the adjustment. The legislature has appropriated \$3.355 billion to fund the cost-of-living adjustment contingent on voter approval of the proposed amendment.

Summary of Comments

The following comments supporting or opposing the proposed amendment reflect positions that were presented in committee proceedings, during house or senate floor debate, or in the analysis of the resolution prepared by the House Research Organization (HRO) when the resolution was considered by the House of Representatives.

Comments by Supporters

Because the vast majority of school districts in Texas do not participate in the federal social security system, the annuity from the
Teacher Retirement System of Texas (TRS) is the only retirement benefit most retired teachers receive. Without having received a
cost-of-living adjustment (COLA) in nearly 20 years, retired teachers have lost considerable purchasing power with their TRS annuity
due to cost increases and high inflation.
 Funding a COLA for TRS retirees will provide the state's retired teachers with muchneeded relief and is a wise use of the state's surplus revenue.

Comments by Opponents

No opposition to the proposed constitutional amendment was expressed during legislative consideration of the proposal.

Dottie Jean Clark



Our Association lost a valued and respected member when Dottie Clark passed away on March 15, 2023. Dottie was a lifetime member and served as the Retiree Association's Vice President from January 2016 through December 2016 and President from January 2017 through December 2019. Retiree Ed DesPlas recalls the early years working with Dottie in the article that follows.

I'll Never Forget Her - Remembering Dottie Clark

Dottie Clark interviewed me in 1977 for the Information Clerk position at the Instructional Television Center. ITV Center was in the W portable building at Richland College; it was a much better location than the previous one in Richland's basement near the Audio/Visual department, she explained to me. The ITV Center was growing and producing new telecourses: an emerging wave of course modalities. An Information Clerk was the link between remote students and their instructors. The position also had a robust list of "other duties as assigned". Her pride in the ITV Center caused me to want that job. I'll never know why she hired me.

I'll never know why Dottie asked me to try to reconcile the study guide receivables and the lease receivables accounts for the ITV Center. I'd never taken accounting; besides that, I didn't know a debit from a credit. But she did ask me to work those accounts. So, I reconciled them.

I'll never know why she was interested in my future. Dottie asked me what I wanted to study at Richland College. Literature was my reply. She suggested that I study accounting.

"Why should I do that?" I asked.

"Because with an accounting degree and the right experience, you can become a vice president of business services at one of the colleges" she replied.

"Me? I could become a VPBS?"

"Sure" said Dottie with a big smirk on her face "They don't know crap!"

She trusted me to get it right, promoting me to Accounting Clerk for the ITV Center and challenging me to take-on increasingly difficult accounting tasks. I'll never know what it was she saw in me.

Dottie encouraged me to reach career peaks: Budget Officer, Director of Business Operations, Dean of Financial Affairs, Vice President of Administrative Services, Executive Vice President, Interim President, Executive Vice Chancellor - Business Affairs. With each step on my path, I would send Dottie a note of thanks. It would be worded something to the effect of "Did you know five years ago that you were hiring the Budget Officer of the DCCCD?" "Did you know you were hiring the Vice President of Administrative Services of Western Nebraska Community College?" "So many years ago, did you know you were hiring the Executive Vice Chancellor, Business Affairs for the DCCCD?"

Each time, "Yes. I knew. How could I not?" was Dottie's reply.

She will always be my first mentor.

I'll never be able to thank her enough for the confidence she had in me.
