To provide adequate time for processing, this application must be filed in the Financial Aid Office 6-8 weeks prior to the beginning of your class. You must also turn in a copy of your Registration Summary/Fee Receipt. TPEG-CE awards may not exceed campus eligibility amounts as funds are limited and are not guaranteed.

- > Students with federally issued Social Security numbers must complete the 2024-2025 FAFSA online at least 6-8 weeks prior to the first day of the CE class or program.
- Students without a valid Social Security number must have a residency code of 1A, 1D, 2B, 2D or 1C on their admissions record and must complete and submit a paper FAFSA and a copy of their signed 2022 federal income tax return to the Financial Aid Office.
